Constitution & Purpose

The Scout Group is constituted in terms of the Rules of The Scout Association, which is a charitable body incorporated by Royal Charter. The Group is a registered Scottish Charity - No SC032095.

Activities & Achievements

This year has seen many activities resume after the Covid-19 pandemic had prevented many activities from taking place for the Scout Group. The Beavers, Cubs & Scouts took part in various indoor & outdoor activities throughout the year. During these activities the Beavers, Cubs and Scouts learn Scouting skills which form part of their program (cooking, first aid, planning for camping trips and putting up tents, etc). Badge work was also part of the evening programs carried out at home, in the Scout Hall and in the park. Fundraising and hall lets resumed this year and raised significant amounts for the Group. During the year a number of grants were received and spent on equipment for the Group (mainly tentage). It is forecast that for the next few years some significant sums will require to be spent to maintain the building, which has been delayed due to Covid. Maintenance is needed mainly on heating and the roof with which there are ongoing issues. Gift aid and the Explorer section contribution to income for this financial year will be realised in the next financial year.

Reserves Policy

The Trustees believe that around 12 months of annual expenditure is an appropriate level of reserves in order to cover the timing differences between receipts and payments and to allow for any unexpected items of expenditure on items of expenditure such as training, premises repairs and renewals.

Independent Examiner's Report to the Trustees of the 175th Glasgow (1st Bishopbriggs) Scout Group

I report on the financial statements of the 175th Glasgow (1st Bishopbriggs) Scout Group ("the Group") for the year ended 31 August 2022 which are set out on pages 3 to 5.

Respective responsibilities of Trustees and Examiner

The Group's Trustees are responsible for the preparation of the accounts in accordance with the Charities and Trustee Investment (Scotland) Act 2005 ("the Act") and the Charities Accounts (Scotland) Regulations 2006 ("the Regulations"). The Group's Trustees consider that the audit requirement of Regulation 10(1)(d) does not apply. It is my responsibility to examine the accounts as required under section 44(1)(c) of the Act and to state whether particular matters have come to my attention.

Basis of Independent Examiner's Statement

My examination is carried out in accordance with the Regulations. An examination includes a review of the accounting records kept by the Group and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from the Trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.




